In accordance with the Myanmar Tourism Law, Section 8, sub-section (b), the Ministry of Hotels and Tourism is exercising its authority under and Section 39, sub-section (b) of the Myanmar Tourism Law, the License Fees, License Renewal Fees, Fines and Service Fee are adopted with the approval of the Central Committee for National Tourism Development.
